NOTICE INVITING TENDER

Sealed Tender is hereby invited from the reputed & experienced carrying contractors for carrying of rice from enlisted FCI Godown, Paschim Medinipur to all School Godowns at 8 (Eight) Blocks & 1 (One) Municipality under Jhargram District as per the following terms and conditions.

GENERAL TERMS AND CONDITIONS FOR CARRYING CONTRACTOR:-

1. Tender Paper will be issued from the District MDM Cell, Jhargram after verifying required documents from 24.05.18 to 05.06.18. Tender will be submitted at District MDM Cell on 06.06.18 from 11:00 AM to 2:00 PM and will be opened at the chamber of Addl. District Magistrate(G), Jhargram on 06.06.2018 at 2:30 PM. Details will be available at the website- www.jhargram.org
2. Under no circumstances Carrying Contractor will receive or deliver less weight, damaged, cut bags/gunnies/packet/bottles of food stuffs from enlisted FCI Godown to MDM Provided all School Godowns.
3. Contractor will maintain a register as per the direction issued by the undersigned & he will be bound to be present it on any day, to obtain information about rice arrival and delivery information.
4. Contractor will have to abide by necessary direction issued by the Nodal Officer, MDM regarding preparation of reports, returns & challans and their timely submission to the office.
5. Contractor have to complete carrying of Rice to the end of all Schools from FCI Godown within 3 (Three) days from the date of receipt of order from the office. There must be arrangement for Weighing of food stuff at the time of receiving at the Block Level Godown. Supply should be made in the day time on working hours.
6. For carrying, rate per quintal of net weight is invited subject to the maximum ceiling of Rs. 35/- (Rupees Thirty Five) only per quintal and rate should be inclusive of loading unloading, weighing, stacking (at Block Godown) and all other incidental charges.
7. The rate quoted should be specific (in figures and words) and unconditional. No over writing or erasing in the rate shall be allowed. If any correction made, it should be authenticated by putting signature in full with seal.

8. District Level Tender Committee (DLTC), Jhargram is the final authority to accept and for final approval of the Tender. DLTC reserves the right to reject any or all tender. Tender Committee reserves the right to negotiate with the lower Tenderer or any other valid Tenderer.
9. Payments will be made subject to the availability of fund. It is binding upon the contractor to continue work throughout the period of contract and delayed payment shall not be accepted as a reason to discontinue the work by the contractor. Outstanding dues will be paid at first and then comes the running payment.
10. Any breach of contract, activities prejudicial to the interest of the project, non-compliance of Govt. Orders etc. Shall lead to the forfeiture of earnest money/security money or both as would be deemed fit by the Authority.
11. No co-operative Society formed by the staff of any MDM Project shall be allowed to participate in the tender.
12. Period of contract will be for 1(one) year from the date of acceptance of Tender by the District Level Tender Committee, Jhargram.
13. The authority may extend the period of contract with same terms and conditions for a maximum period of six months if considered essential.
14. I) In the event of failure of the Carrying Contractor to complete delivery within the specified period the contract will be cancelled and re issued to any other Carrying Contractors as the authority may think fit. No objection in this respect shall be entertained.
II) In case of diversion of the contract to next higher party the differences of transport cost shall be realized from the defaulting Carrying Contractor out of his pending bills or from his security money deposits.
III) In case of two successive instances of failure of transport Carrying Contractor to delivery within specified period, the tender of the Carrying Contractor for the entire contractual period shall be cancelled and security money will be forfeited. Such Carrying Contractors will be disqualified for submitting any tender to the District Magistrate, Jhargram in future.
15. Tenderer must possess vehicular arrangement under his/her control for transportation of such food-commodities.
16. In case of Co-operative Societies other than that mentioned in point no. 11, certificate of exemption regarding earnest money/security money duly recommended by ARCS and an undertaking from Chief Executive Officer of the co-operative society to be submitted regarding participation of the said co-operative society in the tender. Annual Audit report relating to current functioning of the said co-operative society must be produced.
17. Defaulter and blacklisted contractors will not be eligible in this tender process. Suppression of fact in this respect is strictly forbidden.
18. Tenderer will strictly follow the para while submitting tender.
19. Experience for carrying of food-grains in similar type of work (district/block level carrying contractor for MDM/MDM project) for one year is mandatory.

20. Documents necessary for the submission of Tender:

- i) Current & valid trade license, Income Tax/Pan card, professional tax etc (Xerox copies with attestation).
- ii) Earnest money worth Rs 10,000/- (Ten Thousand only) in the form of Bank Draft in favour of District Magistrate, Jhargram (in original).
- iii) In case of Co-operative Society certificate from C.E.O. regarding participation, exemption certificate on earnest money & security money from ARCS Jhargram, Annual Audit report regarding current functioning of the societies etc. (Xerox with attestation).

21. SECURITY MONEY:

Successful Tenderers shall have to deposit security money worth Rs 50,000/-(Rupees Fifty Thousand only) in the form of STATE BANK OF INDIA, ONLINE BANKING /SBI NEFT / RTGS in favour of District Magistrate Jhargram. He will have to enter into an agreement on non-judicial stamp worth Rs 50/-(Fifty). Security money will be forfeited if the contractor fails to perform the duties as per agreement. Security money will be released after six months from the expiry of the period of the contract provided the contract has satisfactorily been fulfilled.


