The sealed quotation will be opened on 31.07.2018 at 04: 00 PM. in the Chamber of District Controller, Food & Supplies, Jhargram.

The undersigned reserves the right to accept or reject any quotation without assigning the reason whatsoever.

The concerned supplier whose quotation will be accepted must supply the selected commodity within ten days from the date of receiving the supply order failing which their offer will be rejected without further notice.

- ii) Rice must be of best quality. Concerned selected supplier will have to supply the desired quantity of Rice upto the specified M.R. Distributors point as will be advised in the concerned supply order.
